

#### **CHILD PROTECTION POLICY**

The British and International Federation of Festivals for Music, Dance and Speech work for amateur festivals everywhere to help create thousands of educational performance opportunities for children and young people each year.

The Federation, and our member Festivals, are committed to ensuring safe environments for children and young people and believe that it is always unacceptable for a child or young person to experience abuse of any kind. We recognise our responsibility to safeguard the welfare of all children and young people, by a commitment to recommend best practice which protects them.

This policy applies to our Board of Trustees, paid staff, Adjudicator members, volunteers, students or anyone working on behalf of the Federation and our member Festivals.

#### We recognise that:

- the welfare of the child/young person is paramount;
- all children, regardless of age, disability, gender, racial heritage, religious belief, sexual orientation or identity, have the right to equal protection from all types of harm or abuse;
- working in partnership with children, young people, their parents, carers and other agencies is essential in promoting young people's welfare.

#### The purpose of the policy:

- to provide protection for the children and young people who participate in our festivals, including the children of festival members;
- to provide staff and volunteers with guidance on procedures they should adopt in the event that they suspect a child or young person may be experiencing, or be at risk of, harm.

#### We will seek to safeguard children and young people by:

- valuing them, listening to and respecting them;
- adopting child protection guidelines through procedures and safe working practice for staff and volunteers;
- recruiting staff and volunteers safely, ensuring all necessary checks are made;
- · sharing information about child protection and safe working practice with children, parents, staff and volunteers;
- sharing information about concerns with agencies who need to know, and involving parents and children appropriately;
- providing effective management for staff and volunteers through supervision, support and training.

The Federation will review this policy each year in November in line with Safe Network guidance or sooner in light of any changes in legislation or guidance. All changes will be communicated to our member Festivals in time for the start of the new Festival year.

#### Creating Safer Festivals for Everyone

The Federation and its member Festivals use the following policies and procedures to create **Safer Festivals** for everyone:

- 1. A single, definitive Child Protection Policy adopted by all Federation Festivals.
- 2. One or more designated Festival Safeguarding Officers (FSO) appointed for each Federation Festival.

- 3. Best practice advice in the form of **Safe Working Practice** and **Festival Child Protection leaflets**, with support and training for all Festival staff and volunteers. Including clear reporting procedures for anyone with a concern about a child.
- 4. Appropriate recruitment and induction procedures for all new Festival staff and volunteers responsible for providing safe environments for everyone attending / performing at a Federation Festival.
- 5. All Festival stewards wear an approved PMF badge. All teachers/parents/guardians/carers are asked to report all incidents of any nature to anyone wearing a Festival identity badge. All reported incidents will be handled in accordance with the Safe Working Practice and Festival Child Protection best practice advice. In addition each Festival will ensure the availability of a quiet area / room where concerns can be expressed in private.
- 6. For the duration of the Festival all teachers/parents/guardians/carers are responsible for the continuous care and supervision of their own children/pupils/vulnerable adults. If they are unable to attend personally, they must delegate their responsibilities to an identified adult and ensure that their children/pupils/vulnerable adults are aware of the identity and name of the person responsible for their care. This includes supervision throughout all Festival venues, performance, practice and changing areas that may be provided.
- 7. No unauthorised photography or video recording is allowed at our Festivals. Where parents/guardians/carers do not wish photos to be taken at all, then the responsible adult attending should ensure that their child/pupil/vulnerable adult is not included in official authorised photos.
- 8. Some children and vulnerable adults may have specific needs in order to take part. If this is the case we ask the responsible teachers/parents/guardians/carers to contact the relevant Section Head (N.B. contact numbers are printed on the Performer's Entry Card or Schedule) for the Festival prior to arrival. The Festival actively seeks wherever possible to meet these needs, but must know beforehand in order to prepare support or to advise that help cannot be provided on this occasion.
- 9. The Festival's Child Protection Policy and approach to Creating Safer Festivals for Everyone is published explicitly in our Syllabus, Programme and on our website. By completing and signing the entry form all parents / guardians / carers and teachers of entrants under 18 (or vulnerable adults of any age) confirm that they give (or have obtained) the necessary consent for the entrants to take part in the Festival. Without consent the entry to the Festival cannot be accepted.

#### **RULES and REGULATIONS**

#### 1. GENERAL

- 1.1. The following rules apply to all sections of the Portsmouth Music Festival. Certain sections have additional rules which will be found at the beginning of the Syllabus and Programme for those sections.
- 1.2. All classes, except those designated OPEN, are for amateurs. An amateur is someone who does not earn his/her livelihood from performance in the section in which s/he seeks to enter the Festival. This also applies to all members of ensembles.
- 1.3. The Management reserves the right to:
  - 1.3.1. Reject any proposed entry.
  - 1.3.2. Limit the number of entries in any class where, because of Government Health and Safety Regulations, the maximum number of entries that can be satisfactorily dealt with has been reached.
  - 1.3.3. Appoint replacement or additional adjudicators and to alter, modify or cancel any of the arrangements detailed in the Syllabus.
  - 1.3.4. Provide an electric piano for use in any section where it is not possible to provide an acoustic instrument.
- 1.4. Performers are responsible for the care of their belongings, including instruments, at all times. The Festival management cannot accept responsibility for any losses incurred.
- 1.5. CHILD PROTECTION POLICY. The Portsmouth Music Festival operates a Child Protection Policy, which has been approved by the British and International Federation of Festivals. A copy of the policy is included in the syllabus and programme. All entrants, performers, members of the audience, and any persons associated with the running of the Festival are to comply with the provisions of that policy.
- 1.6. BEHAVIOUR: Any inappropriate behaviour exhibited in any section of this Festival will result in the person concerned and the teacher/organisation to which s/he belongs being liable to immediate removal, and being banned from the PMF for up to three years. NB: Entry fees are not refundable in this instance.
- 1.7. For large groups, in addition to the MD, one helper per twenty performers will be admitted free.
- 1.8. MOBILE PHONES must be switched off while the Festival classes and/or concerts are in progress.
- 1.9. For copyright reasons the Festival is advised by the British & International Federation of Festivals that the use of video cameras and recording devices of any kind by the audience is not permitted unless the person concerned can show Festival staff a valid copyright permissions licence allowing them to record events, and they have the permission of the adjudicators, the performers (or the parents/guardians/carers of the performers under the age of 18) and in the case of Dance performances the permission of the Dance Choreographers.
- 1.10. Still photography is not allowed during performances, although relations/friends may photograph cup/trophy presentations.
- 1.11. Any complaint or objection relating to the Festival will only be considered if submitted in writing to the Festival Secretary. The decision of the Management Committee in all matters arising out of, or not specifically covered in, these rules is final.

#### 2. ENTRIES

- 2.1. The person submitting and signing the entry form must be 18 years or over.
- 2.2. All entries are to be sent to the individual Head of Section's address, as detailed at the beginning of each section, or entries can be submitted online at portsmouthmusicfestival.co.uk. All entries should be received by the closing date as published in the syllabus and online.
- 2.3. The Committee reserves the right to limit the number of items allowed for each dance or drama school and to return entries should the maximum limit already be attained.
- 2.4. The Committee also reserves the right to split or combine classes to ensure the smooth running of the Festival.
- 2.5. There is a limit to the number of entries that the Festival can accept as each section is restricted to the number of days as specified in the syllabus. Once the maximum number of entries has been reached, the Festival will be unable to accept any more entries.
- 2.6. PAYMENT & POSTAGE
  - 2.6.1. All entries must be accompanied by the full entry fee. A cheque should be included with all postal entries. Please note that entries will not be processed until the entry fees have been received.
  - 2.6.2. All sections will email schedules. Entrants who prefer to receive a printed schedule through the post need to include a stamped, addressed envelope.
- 2.7. Entry fees are as specified in the Syllabus. Cheques should be made payable to PORTSMOUTH MUSIC FESTIVAL. Please do not send cash through the post.
- 2.8. Entry fees are not refundable.
- 2.9. The exact time of each piece must be stated on the entry form.
- 2.10. No performer may perform the same piece in more than one class, or in the same class in different years.
- 2.11. Own choice titles, composers and timings must be advised to the appropriate Head of Section either on the Entry Form or by the date specified at the beginning of each section if different from the closing date. This is because the Festival is under a legal obligation to supply the Performing Rights Society with details of all items to be performed.
- 2.12. If the piece performed is different from that specified by the closing date, the performer will be adjudicated only.
- 2.13. No person will be allowed to take part more than once in any one class unless playing a different instrument, except in a duet or group class, where a second entry is permitted provided a different part is performed.
- 2.14. Performers who are members of more than one choir or group are permitted to perform as a member of each choir or group to which they belong.
- 2.15. Standards are indicated either by age or grade. Where a class is denoted by grade indicators, the entrant should not have taken a higher grade as of 1<sup>st</sup> January of the current Festival year. N.B. The entrant may play a piece on a current examination syllabus one grade higher than the highest grade specified for the class, but they must not have taken the exam at that level. This does not apply to examination classes, which refer to the grade about to be taken.

- 2.16. A Novice is considered to be an entrant who has not been learning an instrument for more than 18 months on 1<sup>st</sup> January of the current Festival year. A Novice in the Woodwind, Strings & Brass sections is considered to be someone who is currently learning his/her first woodwind, string or brass instrument and has only been playing it for up to 18 months on 1<sup>st</sup> January of the current Festival year.
- 2.17. Songs and Dances: Songs and Dances from shows may not be performed in any manner that identifies them with any show currently being staged. Where movement or costume does identify a performance with a show currently being staged in the UK, performance copyright permission is required. It is the responsibility of the performer to acquire this copyright permission and proof will be required by the PMF. However, a "straight" concert performance does not require any copyright permission.
- 2.18. Costume is not permitted in any Speech & Drama class other than essential props. See section for full details.
- 2.19. GROUP CLASSES SPECIFIED BY AGE OR STANDARD
  - 2.19.1. In all music ensembles (including duets), the class entered is to be that of the youngest or least experienced entrant who should play a significant part.
  - 2.19.2. In all Speech & Drama and Dance groups, the class entered is to be that of the oldest entrant.

#### 2.20. TIME LIMITS

- 2.20.1. Entrants and teachers are asked to check and to carefully comply with both upper and/or lower time limits. Failure to keep within the time limits set will mean that the performer will be adjudicated only.
- 2.20.2. The time limits in RECITAL classes are for the TOTAL performance, including introductions and pauses between pieces.
- 2.21. AGE LIMITS: the following criteria apply for age limits:
  - 2.21.1. Age is as of 1st September of the current academic year.
  - 2.21.2. YOUTH CHOIRS/BANDS/ORCHESTRAS all players must be in full-time education, and aged 18 years or under as at 1st September of the current academic year, unless stated otherwise in the section.
  - 2.21.3. Ages must be quoted correctly on the entry form.

#### 2.22. ACCOMPANISTS

- 2.22.1. Performers are responsible for arranging their own accompanist.
- 2.22.2. Accompanists known to the Festival Management Committee are listed in the Syllabus. Performers may contact any accompanist on that list. Performers do not have to use any of the listed accompanists, they may bring anyone of their choice.
  - 2.3. Where appropriate, a hi-fi player (CD player & iPod dock) will be available to provide a backing track.

#### 3. PERFORMING

- 3.1. Performers are advised to be present at the venue at least 20 minutes before the advertised time of their class. Any entrant not present when the class is called will not be allowed to take part unless a valid reason can be given. The decision of the Head of Section will be final.
- 3.2. Times of classes are subject to change at the discretion of the Head of Section. (This may occur in cases where all the participants are present before the advertised time.)
- 3.3. A copy of each Own Choice piece must be handed to the adjudicator's steward at the time of the performance, otherwise the entrant will be adjudicated only. Photocopies may be offered provided an original has been purchased. The photocopy will be retained and destroyed by the adjudicator's steward after the performance.

#### 3.4. PHOTOCOPYING of MUSIC

- 3.4.1. The Festival cannot legally allow anyone to play/perform from photocopied music, and has no choice but to disqualify performers and accompanists who do so, unless before their class starts, they can produce written evidence showing that the publisher's agreement has been sought and given.
- 3.4.2. The only photocopies the Festival can allow in law are:
  - 3.4.2.1. Copies for the adjudicator's use, which will be destroyed at the end of each class;
  - 3.4.2.2. For an awkward page-turn which may hinder a performance. In this instance, the performer/accompanist must show the original, purchased copy and the photocopied page to the Head of Section before the class begins, and receive his/her agreement to its use;
  - 3.4.2.3. Those that comply with current photocopying laws.
- 3.4.3. The Festival has to be strict with this regulation. You are asked to comply with it to avoid unpleasant situations arising during the Festival.
- 3.5. MUSIC CLASSES. Any cuts and omissions in the music being performed must be clearly indicated on all copies provided for the adjudicator and the accompanist (if one is required).
- 3.6. SPEECH CLASSES. Any cuts and omissions in the script being read must be clearly indicated and, in the case of copyright works, the performer is responsible for obtaining the required permission from the owner of the copyright, before the Festival begins.
- 3.7. CHORAL, VOCAL AND SPEECH & DRAMA CLASSES.
  - 3.7.1. No performance should contain swearing or obscene language. Any performance that breaks this rule will be immediately disqualified and the performer may, at the discretion of the section head, be required to withdraw from further classes in that section.
  - 3.7.2. Performers should avoid using material unsuitable for the age of the performer.

#### 3.8. ADJUDICATORS

- 3.8.1. Please note that only Festival officials directly concerned with the section may speak to the adjudicator.
- 3.8.2. The adjudicator can stop a performance at any time.
- 3.8.3. The adjudicator's decision in all cases is final.

#### 4. RESULTS

- 4.1. All performers will be issued with a certificate and an adjudication providing the Festival rules have been complied with
- 4.2. The winner(s) of each class will be announced. Second and third places will be awarded at the discretion of the adjudicator.

- 4.3. Cups and trophies in this festival are awarded for the Commended, Distinction & Outstanding categories (84 marks and above); a cup may be awarded for a Merit at the adjudicator's discretion.
- 4.4. The Festival reserves the right to present cups/trophies not awarded in the published class in other classes or sections in the current Festival, with the permission of the Cup Steward and/or Committee.
- 4.5. All cups and trophies remain the property of the Festival and have to be signed for before being taken away from the Festival.
- 4.6. It is the responsibility of the signatory (or his/her parent/guardian) to suitably insure the cup/trophy while it is in their possession.
- 4.7. Cups and trophies that have been damaged whilst in the possession of the holder will be repaired by the Festival and the invoice for the repair sent to that holder.
- 4.8. If a cup or trophy is lost whilst in the care of the holder, the Festival Committee will hold that person responsible for it. The matter should be referred to the Festival Secretary immediately. It will be the holder's responsibility to have any loss made good.
- 4.9. Holders may, at their own expense, have their name engraved on the plinth or shield only, not on the cup or trophy itself. If in any doubt, please consult the Festival Secretary.
- 4.10. Cups and trophies should be returned in good and clean condition to one of the collection points named on the receipt and in the Syllabus and Programme, by the date below. If returned by post, cups/trophies should be extremely well packed. Damage caused in transit will be invoiced to the sender. Please telephone before delivering a cup or trophy, so that you can hand it over in person. At no time should it be left on a doorstep or windowsill.

#### **Data Protection Policy**

Portsmouth Music Festival collects and uses personal information (referred to in the General Data Protection Regulation (GDPR) as personal data) about committee members, volunteers, performers, parents of performers under 18, teachers and other individuals who come into contact with the Festival. This information is gathered in order to enable the running of the Festival and other associated functions. In addition, the Festival may be required by law to collect, use and share certain information.

Portsmouth Music Festival is the Data Controller, of the personal data that it collects and receives for these purposes.

Portsmouth Music Festival's Data Protection Officers are the Management Committee who may be contacted via the Secretary.

Portsmouth Music Festival issues Privacy Notices (also known as a Fair Processing Notices) to all performers, parents of performers under 18, committee members, volunteers and teachers. These summarise the personal information held about performers, parents of performers under 18, committee members, volunteers and teachers, the purpose for which it is held and who it may be shared with. It also provides information about an individual's rights in respect of their personal data.

#### **Purpose**

This policy sets out how Portsmouth Music Festival deals with personal information correctly and securely and in accordance with the GDPR, and other related legislation.

This policy applies to all personal information however it is collected, used, recorded and stored by Portsmouth Music Festival and whether it is held on paper or electronically.

#### What is Personal Information/ data?

Personal information or data means any information relating to an identified or identifiable individual. An identifiable individual is one who can be identified, directly or indirectly by reference to details such as a name, an identification number, location data, an online identifier or by their physical, physiological, genetic, mental, economic, cultural or social identity. Personal data includes (but is not limited to) an individual's, name, address, date of birth, photograph, bank details and other information that identifies them.

#### **Data Protection Principles**

The GDPR establishes six principles as well as a number of additional duties that must be adhered to at all times:

- 1. Personal data shall be processed lawfully, fairly and in a transparent manner
- 2. Personal data shall be collected for specified, explicit and legitimate purposes and not further processed in a manner that is incompatible with those purposes (subject to exceptions for specific archiving purposes)
- 3. Personal data shall be adequate, relevant and limited to what is necessary to the purposes for which they are processed and not excessive;
- 4. Personal data shall be accurate and where necessary, kept up to date;
- 5. Personal data shall be kept in a form that permits the identification of data subjects for no longer than is necessary for the purposes for which the personal data are processed;
- 6. Personal data shall be processed in a manner that ensures appropriate security of the personal information.

#### **Duties**

Personal data shall not be transferred to a country or territory outside the European Economic Area, unless that country or territory ensures an adequate level of data protection.

Data Controllers have a General Duty of accountability for personal data.

#### Commitment

Portsmouth Music Festival is committed to maintaining the principles and duties in the GDPR at all times. Therefore Portsmouth Music Festival will:

- Inform individuals of the identity and contact details of the data controller
- · Inform individuals of the contact details of the Data Protection Officer
- Inform individuals of the purposes that personal information is being collected and the basis for this
- Inform individuals when their information is shared, and why and with whom unless the GDPR provides a reason not to do this.
- If Portsmouth Music Festival plans to transfer personal data outside the EEA Portsmouth Music Festival will inform individuals and provide them with details of where they can obtain details of the safeguards for that information
- Inform individuals of their data subject rights
- Inform individuals that the individual may withdraw consent (where relevant) and that if consent is withdrawn that Portsmouth Music Festival will cease processing their data although that will not affect the legality of data processed up until that point.
- Provide details of the length of time an individual's data will be kept

- Should Portsmouth Music Festival decide to use an individual's personal data for a different reason to that for which it was originally collected Portsmouth Music Festival shall inform the individual and where necessary seek consent
- Check the accuracy of the information it holds and review it at regular intervals.
- Ensure that only authorised personnel have access to the personal information whatever medium (paper or electronic) it is stored in.
- Ensure that clear and robust safeguards are in place to ensure personal information is kept securely and to protect personal information from loss, theft and unauthorised disclosure, irrespective of the format in which it is recorded.
- Ensure that personal information is not retained longer than it is needed.
- Ensure that when information is destroyed that it is done so appropriately and securely.
- Share personal information with others only when it is legally appropriate to do so.
- Comply with the duty to respond to requests for access to personal information (known as Subject Access Requests)
- Ensure that personal information is not transferred outside the EEA without the appropriate safeguards
- Ensure that all members of the Management Committee are aware of and understand these policies and procedures.

#### Complaints

Complaints will be dealt with in accordance with Portsmouth Music Festival's complaints policy. Complaints relating to the handling of personal information may be referred to the Information Commissioner who can be contacted at Wycliffe House, Water Lane Wilmslow Cheshire SK9 5AF or at www.ico.gov.uk

#### Review

This policy will be reviewed as it is deemed appropriate, but no less frequently than every 3 years. The policy review will be undertaken by the Management Committee.

#### Privacy Notice (How we use personal information)

#### Why does Portsmouth Music Festival collect and use personal information?

We collect and use personal information:

- to process entries to the Festival
- to timetable Festival events
- to provide information about event timetables
- to ensure that the Festival is inclusive
- to produce a printed programme of Festival events which includes the names of performers and to publish the names of winners on the website and in the press
- to organise volunteers to staff Festival events
- to obtain references for volunteers in order to fulfil safeguarding requirements
- to comply with the law regarding data sharing

#### The categories of personal information that we collect, hold and share include:

- Personal information (such as name, age, date of birth and address)
- Relevant medical and special educational needs information

The General Data Protection Regulation allows us to collect and use information with consent of the data subject, where we are complying with a legal requirement, where processing is necessary to protect the vital interests of a data subject or another person and where processing is necessary for the performance of a task carried out in the running of the Festival.

#### Collecting personal information

The majority of personal information you provide to us is given on a voluntary basis in order that we may process the entries to the Festival and provide entrants with details of the timetabling and procedures associated with the Festival. In order to comply with the General Data Protection Regulation, we will inform you whether you are required to provide certain personal information to us or if you have a choice in this. Where we are using your personal information only on the basis of your permission you may ask us to stop processing this personal information at any time.

We hold personal data for all entries and volunteers (except members of the Management Committee) until one week after the Festival is completed. The Festival usually ends on the day of the Gala Concert. Data relating to the Friends of the Festival is kept until membership ceases. Cup receipt forms, containing the name of winner, parent's name (if winner is under 18) contact address, telephone, email and teacher's name are retained until trophies have been returned to the Festival. Personal data for the Management Committee is retained until their membership of the Committee ends.

#### Storing personal data

#### Who do we share information with?

After gaining permission, the Festival will share information with sponsors who have provided awards and national organisations namely:

- Solent Symphony Orchestra
- Ports Fest
- All England Dance

#### Why we share personal information

We do not share personal information with anyone without consent unless the law and our policies allow us to do so. We share data with Solent Symphony Orchestra and Ports Fest in order that they can organise the opportunities awarded to performers given through their sponsorship of the Festival. The Dance Section programme and results are shared with All England Dance in order that dancers who have qualified for regional finals can be identified.

#### Requesting access to your personal data

Under data protection legislation, you have the right to request access to information about you that we hold. To make a request for your personal information please contact the Secretary in the first instance.

You also have the right, subject to some limitations to:

- · object to processing of personal data that is likely to cause, or is causing, damage or distress
- prevent processing for the purpose of direct marketing
- object to decisions being taken by automated means
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed; and
- · claim compensation for damages caused by a breach of the Data Protection regulations

Born in Portsmouth, Emily Saville began trombone lessons aged ten, and quickly became involved in a number of ensembles within the Portsmouth Music Hub. Having completed GCSE and A-Level music at Springfield Secondary School and Richard Taunton Sixth-Form College respectively, she then accepted a place to study trombone full-time at the Royal Academy of Music in London. During her studies, she developed a particular interest in historical performance, receiving lessons from Adam Woolf on the sackbut (also known as the historical trombone), and after

receiving her undergraduate degree, she went on to complete a masters degree in Historical Performance at the Schola Cantorum Basiliensis, Switzerland under the tutelage of Catherine Motuz. Emily is regularly invited to play with groups across Europe, including Ensemble Phoenix Munich (Germany), The City Musick (UK), Ensemble Responsorium (Croatia), Magnificat (UK), Ensemble Irini (France), and the Europäisches Hanse-Ensemble (Germany), recording CDs with the latter in 2022 and 2023. She has performed in various series and festivals, including Abendmusiken and ReRenaissance Basel, and the Lausanne Festival of Improvisation, and she can be heard on discs released by Naxos, Toccata, and CPO. Emily has been successful in competitions internationally, notably winning Early Music Vancouver's Emerging Artist Competition in 2023 and the inaugural British Trombone Society Sackbut Competition in 2022. In June 2024 she will make her solo recital debut with Catacoustic Consort in Tegernsee, Germany. Ever enthusiastic about the art of creative teaching, Emily has taken an active role in learning and participation projects with organisations such as the Orchestra of the Age of Enlightenment, the English Touring Opera, and Glyndebourne Opera House, and she holds a teaching licentiate from the Royal Academy of Music. She is frequently invited to teach in and around Basel, including in both the modern and historical trombone classes of the Musik Akademie Basel. Emily is currently studying for a Masters degree in Historical Trombone Pedagogy at the Schola Cantorum Basiliensis, with the overarching goal of enjoying a career that collectively encompasses historical performance, research, and education.

Gerald has performed with many other musicians and actors, notably guitarists Paco Peña, John Renbourn and John Williams, and performs in a duo with Alison Bendy and with Simon Mayor's Mandolinquents as well as in an occasional Irish "ensemble" with Mick Henry, Bernard O'Donoghue, John Pethica and Tom Paulin. In October 1995 he toured China in a duo with guitarist John Williams playing to audiences of tens of thousands of Chinese guitarists and teaching at Beijing and Shanghai conservatoires. He has been invited back to China more recently with teaching posts at Guangzhou, Beijing and Chengdu.

**Richard Deering** has been an adjudicator member of the British and International Federation of Festivals for well over 30 years, adjudicating at an average of 12 festivals a year, including many overseas festivals, as a piano or brass specialist and generalist.

Although no longer active as a performing brass player, he has given piano performances - as soloist and accompanist - in over 90 countries and has held teaching positions in establishments such as London College of Music, Trinity College of Music, Middlesex University, Cambridge University, Auckland University and New York

State University. Composers of the calibre of Malcolm Arnold, Malcolm Williamson, Edward Gregson, Edward McGuire, Thomas Wilson, Brian Chapple and Charles Camilleri have written piano works especially for him, and for several years Richard had a close performing relationship with Elisabeth Lutyens.

In 2023 he is recording the entire piano works of Hubert Parry and William Wordsworth, as two separate projects, while his recording of Lutyens piano music, recorded on her 70<sup>th</sup> birthday, is due for re-issue.

Richard was also an Adviser to the London Arts Board on contemporary music and jazz. He has also made several commercial recordings in both UK and Japan.

His Federation work included serving on the Central Board of Trustees, Vice-Chair of the Adjudicator's Council and with the administration of the PGCA qualification. He was also one of the presenters at both the Warwick and Leeds BIFF celebratory events in 1996 and 2000 respectively.

Currently he is the Chair of Trustees of Croydon Performing Arts Festival and, was honoured, by being elected as a BIFF Fellow in 2012.

Ann trained to teach under John Hodgson at Bretton Hall, his major influence was the importance of improvisation. Ann continues to be an enthusiastic teacher of improvisation for developing all performance skills.

She believes strongly in the inclusive power of drama, that it offers confidence building, teamwork, and the discipline of controlling body, voice - and nerves. Combining that with her love of the written word, her first degree was English; she counts herself lucky to spend her life talking about what she loves.

In addition to the main Rules & Regulations, the following rules now apply to the Speech & Drama section. Please read these carefully as there are some changes this year.

- All entries needing a recorded accompaniment such as a backing track must be sent as an MP3 or MP4 file via email by Monday 8<sup>th</sup>
  January to pmfspeechanddrama@yahoo.com
- 2. Costume and costume suggestion are NOT permitted. It is suggested that participants in acting classes wear their Drama School uniform or an "all black" practice outfit to avoid any confusion.
- 3. Essential props only are permitted. (Please note if an item of clothing has a specific use within the acting piece it may be worn as an essential prop e.g. a hat worn to denote character such as a witch would be deemed costume suggestion and is not allowed but a hat which is removed in the scene for a specific purpose would be considered an essential prop. Any prop which could not be effectively mimed would also be considered as an essential prop e.g. a wand which is held and used throughout the performance)
- 4. Classes which include singing in the performance should not be predominantly a vocal performance with little dialogue. There should be sufficient dialogue to lead smoothly into the song and there should be a balanced performance with spoken words and song not necessarily equal but it must be remembered that this is the Speech & Drama Section and not Vocal or Choral.
- 5. No performance should contain any swearing or obscene language. (If you are in any doubt about whether a word or phrase would be considered "swearing or obscene language" or could cause embarrassment or offence to an audience member it is advised that you omit or change the relevant words. Please remember that there may be young children in the audience and even mild swearing is therefore unacceptable.) See note below.
- 6. Performers should avoid using material unsuitable for the age of the performer. (This does not necessarily relate to the age of the character being portrayed many young children choose to perform speeches or songs originally performed by adults e.g. Mary Poppins. The concerns are rather with younger children performing work which contains, for example inappropriate sexual references, or explicit references to violence etc.) In group items the material performed should be suitable for the youngest members of the group even if they are not on stage at the time as they will still be exposed to inappropriate material. See note below.

The John Davidson Challenge Trophy will be awarded to the entrant from the Junior Section with the highest aggregate mark from Verse Speaking, Prepared Prose Speaking, Acting Monologue, Shakespeare Solo and Sight Reading.

The Whymark Trophy will be awarded to the entrant from the Junior Section who, in the opinion of the adjudicator, has achieved a consistently good standard & shows promise, but has not been awarded a first place in a solo class.

The Tenth Anniversary Cup will be awarded to the most outstanding solo performance in the Junior Section (regardless of mark) in the opinion of the adjudicator.

He was a dual first study viola pupil of Frederick Riddle and piano pupil of Angus Morrison. He holds a complete suite of performing and teaching diplomas on his first instruments, plus a performing diploma on violin, and an MA in music. He also has a background as an organist and vast experience as a choir trainer and conductor.

Roy has spent most of his career combining teaching, performing, examining and adjudicating. He has taught academic music to A Level, his instruments to diploma level and the violin to RAM Exhibitioners. He has coached numerous orchestral and singing courses and festivals for children and has conducted many adult choral societies performances.
